SALTNEY FERRY C.P. SCHOOL School Uniform and Appearance Policy

Introduction

The wearing of school uniform is positively encouraged, since we believe it provides the children with a sense of identity, a feeling of pride and belonging. It has many advantages. It can help solve the daily problem of "What shall I wear today?" and in the long run it can prove cheaper for parents to dress their children in school uniform.

It is our school policy that all children wear school uniform when attending school, or when participating in a school-organised event outside normal school hours. We provide a complete list of the items needed for school uniform in our school prospectus and in this policy.

The official school colour is burgundy.

Aims and objectives

Our policy on school uniform is based on the notion that school uniform/dress code:

- promotes a sense of pride in the school;
- engenders a sense of community and belonging towards the 'Ysgol Saltney Ferry Family';
- creates the correct attitude look smart, work smart.
- is practical and smart;
- enables pupils to be easily recognisable when out on school visits etc
- prevents children from coming to school in fashion clothes that could be distracting in class;
- makes children feel equal to their peers in terms of appearance;
- stops the need for parents to make daily choices or compete with the fashion market;
- ensures that all pupils look the same regardless of economic well-being
- is regarded as suitable wear for school and good value for money by most parents;
- is designed with health and safety in mind.
- provides durable clothing very often cheaper than other brands.

We are sure you can think of many more reasons why wearing a uniform is of benefit to yourself. Unfortunately where uniform is not worn, children can become the victim of teasing by others, questioning by teachers, poor attitude to work, ultimately resulting in low self-esteem. This is the last thing we want for our children.

School Uniform

Pupils will be expected to wear uniform every day. Reception pupils will change for PE in school as part of their Personal and Social Development. All other pupils should come to school in their PE kit on their specific day. Pupils should wear school shoes and not trainers; school shoes in the main are cheaper.

Items marked * can be purchased from the school complete with embroidered logo. The school also sells a range of other uniform including fleeces, PE kit bags and Reading Bags.

- Grey/black skirt, pinafore or trousers (skirts must be of a sensible length).
- White blouse, shirt or polo shirt
- Burgundy sweatshirt* or cardigan* with the school logo
- A red gingham dress with a burgundy sweatshirt/cardigan (Summer Term only)
- Grey/Black shorts –not sportswear (Summer Term only)
- Shoes flat black sensible shoes not trainers boots may be worn to and from school in bad weather)

- Summer shoes if worn should be black/red sandals that fasten and have an enclosed toe.
- White socks or black/grey tights.
- Coat
- Our Year 6 pupils wear a black sweatshirt with the school logo.
- School Hoodie with the school logo*

PE Kit

In Foundation Phase children will need

- Black Shorts
- Plain white t-shirt
- Black velcro pumps for Gym/Dance
- Trainers for outside games
- School Hoodie (optional)

KS2 Children will need

- Black Shorts
- Plain white t-shirt
- Trainers for outside games
- Plain Black tracksuit
- School Hoodie (optional)

Swimming

- Swimming costume (not bikini)
- Trunks/Swimming shorts –please ensure that they have a drawstring to save any embarrassment.
- Towel

Use of Goggles

The School is following the guidelines of the LA, the Association for P.E. and the Amateur Swimming Association which advise that goggles need only be "allowed exceptionally in school swimming lessons" by pupils who are adversely affected by chemicals in the water. Such requests may be supported by medical advice or by reasoned arguments presented by parents in writing to the Headteacher.

Where goggles are being worn those children will be taught how to remove goggles by "slipping them off the head not by stretching the retaining band."

- Please ensure all of your child's clothing is labelled clearly with his/her name. If items are washed regularly, please rewrite names each time.
- In the summer time we encourage sun hats to be worn at all times when the children are outside. Please apply sun cream before your child comes to school (see Sun Protection Policy)
- All items of clothing should be clearly labelled with the child's name.

Jewellery

On health and safety grounds we discourage children wearing jewellery in our school. The exceptions to this rule are earring studs in pierced ears. We ask the children to either remove these objects during PE and games, or cover them with a plaster, to prevent them from causing injury.

Hair and extreme haircuts

Pupils with long hair should have it tied back for health and safety reasons and to help reduce the spread of head lice. Long hair must be tied back for PE lessons and Forest School sessions.

The school does not permit children to have 'extreme' haircuts that could serve as a distraction to other children. Where pupils have had 'different' hairstyles it has made them stand out and again they can become a victim of teasing. This can also be a means by which pupils push the boundaries of acceptable appearance and can create an attitude of non-compliance with the school rules.

Footwear

The school wants all children to grow into healthy adults. We believe that it is dangerous for children to wear shoes that have platform soles or high heels, so we do not allow children to wear such shoes in our school. Neither do we allow children to wear trainers to school; this is because we think that this footwear is appropriate for sport or for leisurewear, but is not in keeping with the smart appearance of a school uniform. We require all children to wear shoes as stated in the uniform list.

Other items

- Make up is not permitted to be worn by any child of any age.
- Nail extensions are not permitted to be worn by any child of any age.
- Transfer tattoos are not permitted to be worn by any child of any age.

The role of parents

We ask all parents who send their children to our school to support the school uniform policy. We believe that parents have a duty to send their children to school correctly dressed and ready for their daily schoolwork. One of the responsibilities of parents is to ensure that their child has the correct uniform, and that it is clean and in good repair. If any parent would like the school to modify the uniform policy, they should make representation, in the first instance, to the Headteacher. The school welcomes children from all backgrounds and faith communities. If there are serious reasons, for example on religious grounds, why parents want their child to wear clothes that differ from the school uniform, the school will look sympathetically at such requests.

The role of governors

The governing body supports the Headteacher in implementing the school uniform policy. It considers all representations from parents regarding the uniform policy and liaises with the Headteacher to ensure that the policy is implemented fairly and with sensitivity. It is the governors' responsibility to ensure that the school uniform meets all regulations concerning equal opportunities. Governors ensure that the school uniform policy helps children to dress sensibly, in clothing that is hardwearing, safe and practical.

Monitoring and review

The governing body monitors and reviews the school uniform policy through its committee work by:

- seeking the views of parents, to ensure that they agree with and support the policy;
- considering, with the Headteacher, any requests from parents for individual
- children to have special dispensation with regard to school uniform;
- requiring the Headteacher to report to the governors on the way the school uniform policy is implemented.
